State Committeepersons

Several people have asked about the role of a State Committeeman or State Committeewoman. These positions are very important in our Democratic Party of the State of Washington. A brief explanation of the role and responsibilities of these positions is very timely since we have just elected two people to the positions in the 7th who have been long time committeepersons: Bob Esvelt (14 years) and Jackie Bradley (22 years).

The Washington State Democratic Central Committee is the governing body of the Democratic Party in the State of Washington. The WSCCC consists of the state committeewoman and the state committeeman elected from each legislative district and from each county of the State. These positions are elected at the biannual reorganizations of the county or legislative district that they will represent. There are 49 Legislative Districts and 39 Counties in the state so the State Meetings could have as many as 176 State Committee Members at any meeting, but often not everyone can make it. Every member has free access to the microphones to discuss the issue at hand.

The primary duties of the State Committee Members are to serve on their local Executive Boards, support the policies and candidates in their local districts and help the local Democratic Party organization in general. They seek out the opinions, issues and needs that are of concern to the local members of the Democratic Party in order to represent them to the state body.

Since these positions are legally considered to be publicly elected officials, it is very important that the role and responsibility of the position is taken seriously. It is also very important that information about action taken at State meetings is brought back and reported to the people who are represented. One of the longest and most involved tasks at these meetings is the consideration of resolutions that help define our state party goals and concerns. Garrie and Bette Grant are State Committeepersons from Lincoln County and have just been re-elected to these positions. Both of them comment on the importance of the positions in representing the issues of Eastern Washington and the time, effort and financial commitment it requires to do the job well and right.

Each State Committeeman or State Committeewoman is appointed to a committee to assist in the operation of the State Democratic Party organization. Included are Resolutions, Elections, Rules, Communications, Finance, Technology, Affirmative Action and now the Eastern WA Conference Committee. The State Committee Person can request to serve on these committees, but in the end the State organization assigns positions to ensure broad support. By serving on committees they assure that their areas are represented fairly in all decisions and discussions. Larry Ludwig, State Committeeman for Stevens County states that he deliberately serves on the resolutions and platform committees to make sure that Stevens County and Eastern Washington concerns are addressed in areas such as gun control, rural transportation, healthcare, and technology needs.

There are also a number of Caucuses that meet at state meetings and elsewhere. Any active Democrat can serve on these caucuses. One of the caucuses of local interest is the Agricultural and Rural Caucus.

As Bob Esvelt reiterates, "It is a time consuming but rewarding job." Bob should know. He has been a State Committeeman for the 7th LD for almost 14 years and received the Washington State Democrats 2006 Warren G. Magnuson Award for State Committeeman of the Year. Congratulations Bob, for your diligence over the years.

- 2. The essay should be approximately 800 to 1000 words in length.
- 3. Attach a bibliography to the essay listing at least five books, speeches, films, articles or other sources which helped you prepare the essay.
- 4. Mail four copies of each essay to the Stevens County Lady Democrats care of P.O. Box 20, Rice, WA 99167-0020. Include a cover sheet with your name, age, grade and school, along with your address and telephone number (and email address if available). All essays must be postmarked by May 15, 2007

The winner of the competition will receive a \$300 prize. Two runners-up will each receive a \$100 prize. The awards will be presented at the annual Stevens County & 7th Legislative District Democrats picnic on July 29, 2007 in the Old Kettle Picnic Area of Kettle Falls.

Winners of the completion will be notified by June 15, and invited to the July 29 picnic where the first prize winner will be invited to read his/her essay.

The essays will be judged by a panel of judges on the following criteria: content, organization, style/voice, diction/word choice, and mechanics.

The essays will not be returned to you. The three winning essays will be submitted to the Statesman-Examiner and The Chewellah Independent newspapers for possible publication.

Agricultural and Rural Caucus meeting

The State reorganization meeting was held in Olympia January 27th. Besides the election of new officers, there were also meetings for each of the recognized caucuses. The Agricultural and Rural Caucus is always well attended and is a group that is recognized at the State level for its activity during the year.

Eastern Washington is well represented with Chris Zaferes (Okanogan County) reelected Chair; Carolyn Cress (Whitman County) re-elected co-Vice Chair; Larry Ludwig (Stevens County) re-elected Secretary; and Jackie Bradley (Okanogan County) reelected Treasurer. The second co-chair position is open since there was not a representative from the western part of the State in attendance who wished to be elected.

The speaker was Volaria Loveland, Director of Agriculture for the State of Washington. She reminded us that in Washington State agriculture is the number one employer and is only second to Boeing in the dollar value of its annual production. We have 300 different commercial crops in the State and one third of our production is exported to foreign markets especially Canada and Mexico with the Eastern Rim countries becoming increasingly interested in our high quality agricultural products.

It was also interesting to learn that organic farming is growing by 10-12% per year and is currently 7% of our agriculture in Washington State. We are one of the few states to have organic certification that meets the European Union requirements which positions us to be a leader in organic markets.

One of the emphases in the State articulated by Governor Gregoire and assigned to Director Loveland is to develop a strategic plan for agriculture for the State. The last time such a plan was developed was in 1984 and as we are all very aware there have been significant changes in markets and agricultural processes since then. This sounds like the important first step in determining the future of agriculture in Washington State.

Director Loveland expressed her concern with the direction on the part of federal government to equate economic growth in the United States on technology development and to deemphasize agriculture. She believes the direction has been to look to poorer countries to provide the food to feed us and to minimize the need to be self-sufficient when it comes to food production. The current federal structure of agricultural regulations serves to reduce support and separate agricultural types resulting in a divided agricultural community. Those of us in Eastern Washington were sensitive to this issue with the competing needs of wheat farmers and apple orchardists.

The other issue discussed was the State program to assist in identification of where food was grown with our Heart of Washington labels indicating that this product was grown in Washington State. Local grocery stores are beginning to use those labels – ask your store if you don't see them.
